 - a. An electronic submission is acceptable with the understanding that the electronic submission is a true scanned copy of the original unbound proposal. Should your proposal be selected for final selection, an unbound original will be provided to the Procurement Specialist.
3. Part VIII – Proposal Checklist for Submittals on page 92 states bidders are to provide 1 unbound and 5 additional tabbed copies.
 - a. MTTA only needs one electronic copy and an unbound original if your firm is selected for further evaluation.
4. The due date is close to the Thanksgiving Holiday. Will MTTA consider a two-week extension?

5. Page 40, Requirements, please confirm the format is correct and there is no initial Item A missing on that page.
 - a. Confirmed.
6. Page 43 of the RFP document references a performance security.
 - a. This not located in the document and is not required.
7. Please confirm there is no bid bond requirement for this solicitation.
 - a. Confirmed.
